Supervise second- and third-year law students enrolled in the Refugee and Human Rights Clinic who represent individual noncitizens in immigration matters and engage in communitybased education and advocacy in collaboration with nonprofit partners. Cases and projects include asylum, Special Immigrant Juvenile Status petitions, adjustment of status applications, petitions for family members to join asylees in the United States, community organizing and outreach, and advocacy reports and manuals. Focus on helping students develop critical lawyering skills, including interviewing, counseling, fact investigation and development, negotiation, legal research, legal writing, oral argument, problem-solving skills, and development of professional identity and resilience. Co-teach the Lawyering Skills for Clinical Practice course, a two-credit course required for new clinic students across all five clinical programs in which students learn best practices for the core lawyering skills they will need for their clinic work. Teach substantive classes related to the work of the Refugee and Human Rights Clinic, including on defensive asylum and immigration research. Guest lecture in other courses, including 1L Legal Research, Analysis and Communication and Immigration Law.

Develop and oversee the Cumberland Legal Aid Clinic's summer program, including developing two-day "Boot Camp"-style training program for new student attorneys and scheduling case rounds, seminars, lunch and learns, and other learning opportunities for summer student attorneys. Teach "Boot Camp" classes and seminars on client interviewing and counseling, working with interpreters, client-centered and trauma-informed lawyering, cultural humility, and research.

Member of the Maine Law Diversity, Equity, and Inclusion Committee and lead of the Committee's Events Team. Organize meetings for the Events Team and assist with the planning and execution of events that bring diverse voices to Maine Law and otherwise advance the work of the DEI Committee.
